Chennai, May 25: In the result of the Union Public Service Commission's (UPSC) civil services exam 2022, 933 candidates recommended for IAS, IFS, IPS and other services. A record 151 Kingmakers students have emerged victorious in the recently announced UPSC results out of 933 candidates appeared for the 2022 exam.
