# Early screening for foot problems need of hour: Vijay Viswanathan

Chennai, Aug 8: Dr. Vijay Viswanathan, Managing Director & Chief Physician MV Hospital for Diabetes and Prof M Viswanathan Diabetes Research Centre Royapuram led a national drive "Save the Feet, keep walking campaign" in 2022 across India with the National Research Society for Study of Diabetes in India (RSSDI), the largest organisation of Diabetes Care professionals in the world.



The main aim of the campaign was to assess the foot for Loss of Protective Sensation (LOPS) in people with diabetes to detect neuropathy at early stage to prevent Diabetic Foot complications. The HCPs across India joined this 1-month long campaign
