# City Union Bank net profit rises 13% to Rs. 286 crore

Chennai, Feb 1: City Union Bank delivered robust double-digit growth across all major financial indicators in the December 2024 quarter, alongside a notable improvement in asset quality.

The bank's net profit rose by 13% to Rs.286 crore for the quarter ending December 31, 2024, up from Rs.253 crore in the same period last year. This growth was fueled by a significant rise in operating profit, despite an increase in provisions.

Operating profit surged 20% to Rs.436 crore, compared to Rs.364 crore a year earlier, according to the bank's statement. Meanwhile, provisions (excluding tax) and contingencies climbed to Rs.75 crore, up from Rs.46 crore in the previous year.

Interest income also recorded a 14% increase, rising to Rs.588 crore from Rs.515 crore.

The bank's net interest margin (NIM) improved slightly to 3.58%, up from 3.5% in the corresponding quarter last year.

City Union Bank also reported strong growth in deposits and advances. Deposits rose 11% to Rs.58,271 crore from Rs.52,726 crore, while advances expanded 15% to Rs.50,409 crore from Rs.44,017 crore in the previous year.

For the nine-month period ending December 31, 2024, the bank posted a net profit of Rs.836 crore, reflecting a 10% increase from Rs.761 crore in the same period last year.
