Windies oust England for 2nd win

ITF Women's Open from Feb 15

Mumbai, Feb 12: Head coach of the West Indies team Darren Sammy said on the match eve on Tuesday that Mumbai as a venue has been "kind to us in World Cups".

Indeed, Mumbai has been kind to the Windies, and their spin variety of off-spin Roston Chase (2/29), left-arm Akeal Hosein (1/32) and left-arm wrist spin Gudakesh Motie (3/33) complemented their batters brilliantly to help the 2012 and 2016 champions post their second win, by 30 runs, and give themselves a high chance of making it to the Super Eight from Group C as they only have to contend Nepal and Italy.

England, bowled out for 166 in 19 overs, need to win their remaining two matches against Italy and Scotland to advance, which should not be a difficulty for the 2010 and 2022 winners.

On a better batting pitch than the adjacent one on which India played against USA last Saturday, the West Indies did enjoy what the Wankhede Stadium centre pitch offered. Left-handed Sherfane Rutherford's career-best 76 not out (42b, 2x4, 7x6) and his 61-run partnership for the sixth wicket with former captain Jason Holder (33, 17b, 1x4, 4x6) gave them a total of 196/6 after being put in to bat by England skipper Harry Brook.

Roston Chase (34) did his best to build the innings after both the openers, Brandon King and Shai Hope fell inside the first two overs to Sam Curran and Jofra Archer, respectively.

In-form Shimron Hetmyer and another former captain Rovman Powell scored 24 apiece with the left-handed Hetmyer hitting two sixes to lend crucial hands on a fine batting surface of the

Wankhede.

Rutherford is not new to India. The 27-year-old left-hander from Guyana turned out for Delhi Capitals in 2019, Royal Challengers Bengaluru in 2022 in the Indian Premier League but it was with Gujarat Titans in 2025 that he had more success. He may not have the numbers and scores like a Chris Gayle or a Rohit Sharma in T20s, but he is known for his striking prowess.

In the 47 T20s that he played coming into this match, Rutherford averages less than 20. His quick scoring is what his team expects him to do. He has been maintaining his strike rate in the late 140s. On Wednesday, he showed his six-hitting abilities in front of the 20,000-plus crowd, walking in at No. 5 when Hetmyer fell after promising much.

Bengaluru, Feb 12:

Days after India's thrilling Davis Cup win over the Netherlands, Bengaluru is set to host another prestigious international tennis tournament - the fourth edition of the KPBT Trust ITF Women's Open W100 Bengaluru 2026. The tournament, the biggest ITF women's tennis tournament in India, will be held at the S.M. Krishna Tennis Stadium in Bengaluru from February 15 to 22. The ITF W100 category offers significant WTA ranking

points and serves as a bridge between the ITF and WTA Tours.

The event features a 32-player singles main draw, a 32-player qualifying draw, and a 16-team doubles draw, with the main draw commencing on February 17.

India's top-ranked female player Sahaja Yamalappalli, nation's top-ranked junior Maaya Rajeshwaran Revathi, Shrivalli Bhamidipaty and Vaishnavi Adkar have been awarded wildcards into the main draw.

For Indian players, the tournament offers valuable exposure against higher-ranked opponents and the opportunity to earn important ranking points on home soil.

The international field is led by Austria's Julia Grabher (WTA No. 79), Australia's Talia Gibson (WTA No. 112) and France's L'olia Jeanjean (WTA No. 117), last year's runner-up, who returns to Bengaluru aiming to go one step further. Other notable names include Thailand's Lanlana

Tararudee (WTA No. 126), Belgium's Hanne Vandewinkel (WTA No. 135), Australia's Taylah Preston (WTA No. 151), Great Britain's Harriet Dart (WTA No. 178), Polina Iatcenko (WTA No. 163), Manachaya Sawangkaew (WTA No. 212), who won the Mumbai Open last weekend, and Russia's Erika Andreeva (WTA No. 328), sister of world No. 7 Mirra Andreeva, underlining the depth of the competition.
