2) Particulars of the proposed alteration:
The company intends to deploy the unutilized amount of ₹15.00 Crore towards a new object of meeting the working capital requirements to address increased demand due to rapid business growth and project expansion.
3) Reasons/justification for the variation:
The capital expenditure envisaged is not required to be spent at this juncture and it may take a while for the company to incur this investment. Considering additional contracts/projects bagged by the company, it became essential to ensure adequate working capital to execute these works in a timely and cost-effective manner which will improve both revenue and profit of the company.
According to the prospectus dated March 18, 2024, the company initially projected a capital expenditure of ₹15 Crore from IPO proceeds. These funds were oriented towards purchase of new high-tech machinery in the execution and construction of infrastructure projects. As of today, we do not see any requirement of funds in this area as Machinery and Equipment Term Loans is easily available on reasonable cost.
The management of AVP Infracon Limited has evaluated and realized that spreading payment over a loan term also helps match the cost of new equipment to its useful lifespan. Moreover, the Machinery Loan payment can be timed to match the equipment value over its useful years rather than taking a huge cash outflow upfront.
Therefore, the funds earmarked for capex in "AVP Infracon LIMITED" are being proposed to be diverted to other areas where these funds can produce shareholder value.
Meanwhile, the requirements of the company have been either met through alternative means or have changed as follows:
a) AVP Infracon Limited has fully utilized ₹30 crore from IPO proceeds for working capital as per the prospectus dated March 18, 2024.
b) Initially, ₹15.00 crore was allocated for Incurring capital expenditure, but the company no longer requires these funds as Machinery and Equipment Term Loans is easily available on reasonable cost and repayment can be timed to match the equipment value over its useful years rather than taking a huge cash outflow upfront
c) In the company proposes to divert the unutilized Capex funds (₹15.00 crore) into working capital to address increased demand due to rapid business growth and project expansion.
d) The company seeks approval to reallocate these funds to support continued operations and maximize shareholder value.
4) Effect of the proposed variation/alteration on the financial position of the company:
The proposed alteration will improve liquidity, support growth, and enhance operational efficiency, without affecting the company's financial stability or capital structure.
5) Major Risk factors pertaining to the new Objects:
Change in Government Policies, Adverse Market conditions, poor performance of economy, Regulatory overhaul, timely receipt of receivables due, unforeseen circumstances in spite of best efforts are the major risk factors that might affect the company despite best efforts taken by the company.
